During regular case management meeting, [REDACTED] advised that on 12/08/14, at approx 20:15, during his internet session in OPC1, he was physically assaulted by CSO [REDACTED] & a local CSO. [REDACTED] states that a local CSO turned off his computer screen, following giving a 30 second "time left" warning. [REDACTED] verbally protested as he had not logged out of Facebook & attempted to turn on his screen. The local CSO allegedly pulled [REDACTED] fingers backwards in an attempt to prevent him from touching computer. The local CSO then began yelling in [REDACTED] face, following [REDACTED] protest at his hand being twisted. [REDACTED] then attempted & allegedly pulled [REDACTED] backwards in his chair.
