<p>At approximately 2:30pm on 23rd October 2014, [REDACTED] was speaking to Case Manager [REDACTED] about the follow up process/ lack of follow up process of two incidences whereby [REDACTED] complained about inappropriate sexualised behaviour by an IHMS staff member and a Wilson Security staff member. [REDACTED] stated the following, via Farsi interpreter [REDACTED]:</p> <p><i>„am still thinking about ending my life, but I am scared that they will mistreat my dead body. I am trying to think of a perfect solution. People think that if I am smiling or if I look like I am ok, that I am feeling ok, but I am not.”</i></p> <p>[REDACTED] also stated that she feels this way due to insufficient outcomes from her complaints to both IHMS and Wilson Security. [REDACTED] stated that another Asylum Seeker confirmed that they have seen [REDACTED] (Wilson Security staff member whom she complained about) still working at RAA and SAA last week. [REDACTED] stated that said that this makes her feel very unsafe.</p> <p>[REDACTED] disclosed that she has experienced sexual abuse from men in her past, and as such the lack of resolution to these complaints is playing in her mind and makes her feel very unsafe at RPC3 and encourages her to end her life.</p>
