Detail of Information
 At 11:30am-12:30pm on 27th Nov 2014 CM [REDACTED] spoke with [REDACTED] and her husband [REDACTED]. [REDACTED] made the following comments which escalated throughout the conversation. [REDACTED] was very angry today, more so than CM has observed in the past.

- "If I want to kill myself there can be everyone around or no one around and I will do it. I don't have to tell mental health because there is nothing they will do to change our situation, that's why I told them I am fine."
- "If I kill myself I will do it in a way where no one knows and they will find my body two days later."
- "I have given myself two weeks [to see change for herself and her husband and if not I will kill myself]"
- "I will tell mental health that I want to kill myself, and it will happen anyway."
- "Just make sure I am not put on high watch because if I am I will definitely do something right in front of them in the next few days."

CM [REDACTED] is very concerned about [REDACTED]'s mental health and has assessed a serious risk. [REDACTED] and her husband [REDACTED] are both very frustrated with the lack of outcomes for them in regards to their time in Nauru, and their respective health/ mental health issues. CM [REDACTED] was able to stabilise their mood at separate times, however towards the end of the conversation both [REDACTED] and [REDACTED] both became very frustrated and angry.

CM is concerned that they will make high risk decisions today from a place of anger and hopelessness.

Note: [REDACTED] was scheduled for a Psychiatrist appointment on 26.11.2014 however this appointment was rescheduled due to flight issues, and has not yet occurred.
