Incident one:

I (SCA CSPW [Redacted]) was speaking with [Redacted] ([Redacted]) in the grass above the security entrance of area nine. [Redacted] informed me that her husband [Redacted] ([Redacted]) had reported four months ago to her that he had been in a car with his [Redacted]-year old son with two [Redacted] Wilson's security Officers. [Redacted] stated that according to [Redacted], [Redacted] was sitting in-between himself and the security officer. [Redacted] stated that this car was taking the two from area nine to IHMS RPC3. [Redacted] alleged that [Redacted] informed her that their son [Redacted] had said to [Redacted] that one Nauruan Officer had put his hand up [Redacted] shorts and was "playing with his bottom". [Redacted] then reported that [Redacted] stated that he removed [Redacted] from the middle of the car and placed [Redacted] on his lap but did not say anything as he feared the two [Redacted] Officers in the car with him. [Redacted] informed CSPW [Redacted] that she had reported this to Immigration Officers in Brisbane when she was recently medivaced (within the past two weeks).

Incident two:

During the same conversation as above [Redacted] informed me that approximately five months ago a [Redacted] Officer had ran his hand down the back of her head and head scarf and said to her "if there is anything you want on the outside let me know, I can get you anything". [Redacted] reported to CSPW that she has not seen this Officer recently in RPC3 but had seen him on several occasions in RPC1. [Redacted] stated that she was able to identify him on sight. [Redacted] described the Officer as [Redacted] thin, short and perhaps between 35-45 years old. [Redacted] stated this occurred at the front guard's entrance to area nine.
