At 12:40, Child Protection Case Manager, [Redacted] was walking with Farsi Interpreter, [Redacted] past Area 4. Interpreter greeted two women sitting in the smoking area of Area 4. They stopped the interpreter by calling to her. One woman (later identified as [Redacted] conversed with Interpreter in Farsi. The Interpreter relayed to Case Manager that one of the women is upset because she was on a bus this morning on her own, and a local guard "touched her body".

The woman indicated through the interpreter that she wanted this passed on to her case manager, and said her case manager was [Redacted]. It was then that the woman identified herself as [Redacted], Boat [Redacted]. [Redacted] said that he would notify case worker of information.

[Redacted] was visibly upset, and was being consoled by the other woman (unidentified) with her.
