At approx. 18:00 CW [Redacted] was talking with [Redacted] and [Redacted] near the playground. [Redacted] advised that [Redacted] "catch all the girls." CW told [Redacted] she didn't understand. [Redacted] said that [Redacted] was walking "over there" pointing to the volleyball area and that [Redacted] "caught" her. [Redacted] then said "me too."

CW asked [Redacted] what happened to her. [Redacted] said she was watching a movie and he caught her. When CW asked [Redacted] what she meant [Redacted] demonstrated by pinching herself on the bottom and pointed to her vagina. CW asked if this is what happened to [Redacted] and [Redacted] and [Redacted] confirmed.

CW asked if the girls had told anyone. [Redacted] said that she had told her dad and that he had told her to stay away. [Redacted] said that [Redacted] did this to 'all the girls.' CW asked if this had happened to anyone else and [Redacted] advised that it had also happened to [Redacted].
