I heard him then call Whiskey 3 via radio. I went to Foxtrot 1 to prepare an Information Report and I was able to identify the asylum seekers involved in this matter (the boy child) and (as the adult female). Action Taken: Romeo 1 and Command 4 Notified. Romeo 1 contacted control at 1300 hours Identify is the mother of the victim Whiskey 3 spoke to both parents of the child victim husband and explained the type of behaviour towards a child was not acceptable.
