At a table near here, I observed a female asylum seeker bang a young boys head into the back of the chair he was seated in. She hit his head into the chair about three times. I heard the boy was crying but after this woman hit his head against the back of the chair, the boy stopped crying.</p> <p>I saw that Whiskey 3 Bravo was in the mess so I went and told him what I had seen. I heard him then call Whiskey 3 via radio.</p> <p>I went to Foxtrot 1 to prepare an Information Report and I was able to identify the asylum seekers involved in this matter as [Redacted] (the boy child) and [Redacted] (as the adult female).</p>
