He was bleeding from the left wrist. There were 3 cuts to his left wrist area. There was blood on the floor and drops of blood in the hallway leading to the room. CSO called a Code Blue over the radio. moved to the hallway, still standing. R2 CSO's arrived a short time later and took over the first aid of instructing him to lie down and raise his left arm above his head. Dressings and pressure were applied to the left wrist area. exhibited signs of shock in that he was cold to touch, was shivering slightly and had a weak pulse. Blankets were put on him to keep him warm. IHMS staff members arrived at 1224hrs. was taken to IHMS RPC1 by ambulance under escort. He was placed on a high Welfare watch prior to leaving RPC3. A search of the room located a razor with the blade removed. The blade used to self harm was not located. The code was stood down at 1236hrs. Action Taken: 1. IR complied 2. R1 and R2 attended 3.
