Case worker [Redacted] and [Redacted] interpreter went to see [Redacted] at her accommodation. [Redacted] spoke at length about her declining mental health and her desire to have a break from the environment of RPC Nauru. During the conversation [Redacted] stated the following

- [Redacted] experiences ongoing nightmares
- [Redacted] will sometimes 'claw' herself during her sleep
- [Redacted] is worried that she may harm herself in her sleep
- [Redacted] stated 'I don't want to end my life, the idea comes to me momentarily but I will not act on it'
- [Redacted] feels like she is 'at the end of her rope'
- [Redacted] stated that 'it might happen that I might commit suicide to end my life'- [Redacted] clarified that her concern was that she may commit suicide in her sleep and she confirmed that she will not harm herself while she is awake.
- [Redacted] advised she is 'more down than normal'

CW [Redacted] and [Redacted] continued to speak generally about her mental health. [Redacted] conversation was future focused and she presented as calm. CW [Redacted] advised she will speak to SCA Management about [Redacted]s concerns [Redacted] is currently linked with IHMS mental health.
