On the 1/09/2015 at approximately 10:15am SCA staff member [REDACTED] was walking through the volley ball court at RPC3 and stopped to talk to [REDACTED] (s). During the conversation staff inquired as to why he was not at school (Nauru College) today. He replied that he and no one else was at school because of a fight yesterday. Staff asked if he was ok. He replied yes, but that he did not want to go to school. [REDACTED] then disclosed that Nauruan children had pulled a knife on them at school yesterday. Staff asked him to clarify and he stated that the Nauruan boys were allegedly touching 'the girls' and they allegedly "pulled a knife on [REDACTED] [REDACTED] [REDACTED]. Staff asked if this had been reported and [REDACTED] answered no and that he might talk to Connect when they arrived at RPC3 at 11am today, for a meeting with the children not attending school.
