SME	Topic
HIGH	<p>[REDACTED]</p> <p>Recent deterioration in mental state, and is now being supported and monitored at IHMS Clinic. Discussions regarding future treatment options ongoing. Placed on HI SME 22/7/16 due to increased distress related to auditory/visual/tactile hallucinations that [REDACTED] has been experiencing with increasing frequency.</p> <p>IHMS: Remains mentally unwell taking medications reluctantly and requiring reassurance from familiar staff. Continues to experience distressing hallucinations of a man trying to kill him. These episodes are occurring more frequently Eating small amounts of food drinking tea and water. Whisky team remain in attendance, line of sight. Friends welcome to visit. Dr [REDACTED] to review later this pm. Remain On HIGH SME for follow up review tomorrow.</p> <p>SP: Nil concerns, interacting with familiar security staff.</p> <p>CM: Recognised his CM, had a positive engagement with her and asked her to come back to visit.</p>

 Has been displaying intermittent bizarre behaviour since 18/7/16, currently in IHMS Clinic since 22/7/16 due to this. Required rehydration therapy, poor oral intake, mute.
 IHMS: Remained at IHMS another night, still exhibiting bizarre behaviour and disruptive at times. MH review 24/7/16 by Psychologist– initial review he was unresponsive, mute. Started to converse with Psychologist with female interpreter – admitted to MH that he had taken large quantities of cannabis and ‘wara galas’ recently prior to recent behaviour. Refusing to engage when DR ██████ attempted to review. Medically cleared and for discharge from the Clinic to his own accommodation. SME MODERATE commenced due to moderate risk of SH & harm from others. For follow up mental health review tomorrow.

SP: No real social support network since Jan/Feb when he was displaying bizarre behaviours moaning and yelling around the compound. To engage and monitor SME Moderate.

CM: CM visited yesterday. ██████████ responded to questions. Reports he had eaten breakfast

██████████
Raised by Wilsons – CA was approached by ██████████’s friends expressing concern for his wellbeing. They report that he has not been eating and has become withdrawn over the past 10 days, not engaging with anyone and doesn’t want help. CA attempted to engage (normally engages well), but would not engage with him at all.

Noted to be on Missed Meals Register not attending meals for past 3 days. Having hydration in the IHMS clinic after a code blue 23/7. Has recently been on medication that can exacerbate a low mood. (now ceased). No food/fluids the two days admitted to the clinic and refusing to communicate for a MH assessment with Dr ██████. Refusing food and fluid. Left the clinic at 1700hrs. Placed on a MODERATE SME, for follow up and review 26/7/16. FFR incident report commenced and sent.

IHMS:

SP: Not seen since the CA found him collapsed on his bed and admitted to IHMS.

CM: Not seen today as yet, will try to see this afternoon

IHMS: MH CM continues to support and encourage coping strategies. Call from Whisky team this am requesting ██████ be able to see CM. ██████ reported that x 2 of the Wilsons guards were taunting him and making him feel agitated. For Psychiatrist review 27/7.

IHMS: Did not attend for medications last night

Discuss every Wednesday unless presentation requires it more frequently

IHMS: Did not attend medications again. Reported to MHN that he was going to Lorengau to see his wife and daughter. MO appointment 26/7.

██████████
 Raised by ABF – ██████████ presented to Shopfront Thursday, stating that he cannot settle in PNG, despite being a refugee, due to his sexuality. He has given ABF/PNGICSA a week to give him a suitable alternative, or he has threatened to stitch his lips together and go on a hunger strike. Was adamant that he does not want to engage with IHMS MH currently about this. PNGICSA have engaged with ██████████ and will speak with him again next Thursday at Shopfront.
SP: Contact with CA. he did not wish to discuss his issues but reports he is “fine”
CM: Did not want to see MH or anyone else and stated is still expecting an answer from ICSA on Tuesday.
IHMS: Not able to be found when MHT have attempted to review. Today informed he is in East Lorengau

██████████
 Raised by BRS – ██████████ reports to CM that he has not felt like this before, stating he feels 99.99% full and can't take anymore. Has been trying to engage in strategies to help cope with the stress which is making him vomit, and does not want to burden his friends. Became tearful and would not engage further, stated would talk to CM tomorrow. Friends and other CM's in Mike compound have commented on how low he looks presently.
IHMS: Counsellor attempted to consult and support. Informed he is in east Lorengau.
CM: Most likely be seen tomorrow, awaiting an interpreter.
SP: CA attempted to see, will retry later today.

██████████
 Brought to IHMS 23/7 clinic after a Code Blue. Aggressive and combative requiring sedation. Reviewed by MHN 24/7 .Extensive history of T&T now displaying depressive symptoms with psychotic features. Reports he saw his daughter in the room last night worried about her whereabouts now as he has to make sure she eats and is ok. Reviewed by Dr ██████████ .To remain in IHMS clinic overnight.

██████████
SP: Referral to MHT due to feeling low ,on medication ,not working.Has stomach pain when he eats .Physically shaking.Threatened to harm himself if something is not done in 5-6 hours. Threatened to kill himself with a razor blade.Placed on HIGH WW.
IHMS: Reviewed by MHN. Negotiated to continue to see mental health . Contracted not to harm himself .Has a follow up appointment 27/7/16. No SME at this time.
